WHO CAN APPLY

Candidates must be at least 18 years old, registered to vote in San Miguel and reside within the District boundaries. Board Members are not required to have experience related to district services, but are expected to prepare for Board Meetings, review meeting materials, and work with other board members, district staff, and residents



OPEN VACANCIES

There are three available seats; two which are four-year term beginning in December 2026 and ending December 2030, and one that is a two-year term beginning December 2026 and ending December 2028.
